## CHEMICAL INFORMATION

### fragrant thick bleach

Powerful thick formula effective against all pathogenic organisms. Contains added detergents for improved cleaning. Pot-pourri fragrance keeps drains and toilets fresh and sweet smelling.

### DANGER

Contact with acids liberates toxic gas. Causes severe skin burns and eye damage. Very toxic to aquatic life with long lasting effects.



### PERSONAL PROTECTION EQUIPMENT



### PRECAUTION PHRASES

Keep out of reach of children. Wash hands thoroughly after handling. Avoid release to the environment. Wear eye protection, protective gloves. IF SWALLOWED: rinse mouth. Do NOT induce vomiting. IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get immediate medical attention. Collect spillage. Store locked up.

## TECHNICAL COMPOSITION & FIRST AID

**Composition** Sodium hypochlorite, sodium hydroxide, nonionic and anionic surfactants.  
**Appearance** Clear liquid  
**Colour** Pale yellow  
**Viscosity** 250 Centistokes  
**Density** 1.078  
**pH** >12  
**Activity** 4.5%  
**Fragrance** Pot Pourri / slight chlorine

### Symptoms / Injuries

**Inhalation** : May cause respiratory irritation. **Ingestion** : Burns **Skin Contact** : Burns **Eye Contact** : Causes serious eye damage.

### Basic First Aid Measure

**Inhalation** : Remove person to fresh air and keep comfortable for breathing. **Ingestion** : Do NOT induce vomiting.;Rinse mouth;Drink plenty of water;Get medical advice/attention. **Skin Contact** : Wash skin with plenty of water;Take off immediately all contaminated clothing and wash it before reuse.;Get medical advice/attention. **Eye Contact** : Rinse cautiously with water for several minutes.;Remove contact lenses, if present and easy to do. Continue rinsing.;Get immediate medical advice/attention.
